VI. New Business

Unfinished Business, New Business, and matters of importance may be presented, at the Chair's discretion, one-half hour after the convening of the business session on Friday morning.

RULES OF ORDER FOR GENERAL COUNCILS AND DIOCESAN SYNODS OF THE REFORMED EPISCOPAL CHURCH

- 1. The business of every meeting shall be introduced with prayer.
- 2. The Minutes of the sessions of the preceding day shall be read every morning at the opening of business, unless the house shall otherwise determine.
- 3. The President shall appoint the several committees, unless the canons of the church shall otherwise specify.
- 4. When the President takes the chair, no member of the house shall continue standing, or shall afterward stand up, except to address the chair.
- 5. No member shall absent himself from the sessions of the house unless he have leave, or be unable to attend.
- 6. When any member is about to speak in debate, or deliver any matter to the house, he shall with due respect address himself to the President, confining himself strictly to the point in debate.
- 7. No member shall speak more than twice in the same debate without specific leave, by vote of the house.
- 8. A question being once determined shall stand as the judgment of the house, and shall not again be drawn into debate during the same session, unless with the consent of two-thirds of the house.
- 9. While the President is putting any question, the members shall continue in their seats, and shall not hold any private discourse.
- 10. No motion shall be considered as before the house unless it be seconded.
- 11. Reports made by the various Boards and Committees to any Council (or Synod) of the church are officially received upon presentation to the house, and are the subject of its action only insofar as they embody recommendations which require specific authorization or approval under the canons of this church.
- 12. When any question is before the house, it shall be decided upon before any new subject is introduced, except for the question of adjournment.
- 13. All questions of order shall be decided in the first instance by the Chair, without debate. An appeal, however, may be made from the decision of the Chair by any member of the house; said appeal requiring a two-thirds majority vote to be sustained.
- 14. The question on motion of adjournment shall be taken before any other, and without debate.
- 15. When the house is about to rise, every member shall keep his seat, until the President shall leave the Chair.
- 16. A call to prayer shall always be in order, when made by a member entitled to the floor; and in such case the Chair shall designate the person(s) whom he desires to lead in that service.
- 17. These Rules of Order shall remain in force until altered or suspended by the Council, two-thirds of the members present voting for such alteration or suspension.

MINUTES November 5, 2015

MORNING SESSION

The One Hundred Thirty-fifth Council of the Diocese of the Northeast and Mid-Atlantic of the Reformed Episcopal Church convened on Thursday, November 5, 2015, 10:00 a.m., at St. Paul's Reformed Episcopal Church, Oreland, Pennsylvania. The service of Holy Communion was presided over by the Most Rev. Royal U. Grote, Jr. The sermon was delivered by The Rev. Howard Currie.

Registration for the Council took place prior to the morning's Communion service. The roll was taken as the participants arrived, and the Secretary confirmed that a sufficient number were present to constitute a quorum. There were 74 in attendance qualifying to vote at the proceedings. Offering in the amount of \$780.00 from the service of Holy Communion was designated to Anglican Relief and Development Fund for flood relief in South Carolina.

Bishop Hicks declared the Council in session at 1:30 p.m. He called on the Rev. John Milligan to open Council with prayer.

The Report of the Committee on Credentials was given by The Very Rev. William Jenkins, Sr. He noted that this would be the last time that Anglican Uka Ndi Igbo Church would be listed in this report. Rev. Jenkins moved that the recommendation of the Committee be accepted; it was seconded and approved. Additionally, Rev. Jenkins suggested that, in the future, those who wish to send forms digitally may do so directly to him, and he will acknowledge receipt.

REPORT OF BISHOP LEONARD W. RICHES

To the One Hundred Thirty-fifth Council of the Diocese of the Northeast and Mid-Atlantic of the Reformed Episcopal Church

Dear Brothers and Sisters in Christ:

Grateful for the privilege of continuing to serve Christ and His church in episcopal ministry I offer the following summary of my activities during the past year.

My service in the Diocese was carried out largely in connection with the ministry of teaching and formation for Christian service through the agency of the Theological Seminary of the Reformed Episcopal Church. In that regard, I once again taught the course on *The Thirty-nine Articles of Religion* during the ten-week Trinity Quarter of the 2014-2015 academic year. The completion of this course in late November, 2014, marked the conclusion of my fiftieth year of teaching at RES, a tenure which began in September, 1965. Subsequently, I submitted notice of my retirement as an active member of the teaching faculty to the Chancellor, Dean, and Board of Directors, effective with the conclusion of the 2014-2015 academic year. I am deeply grateful for the opportunity afforded me throughout these five decades of serving Christ and His church in conjunction with the vital work and ministry of the Theological Seminary.

Throughout the past year I have also continued as a member of the Board of Directors of the Seminary, attending each of its scheduled meetings. However, having now served as a member of the Seminary's governing board for nearly thirty years, I have requested that I not be renominated to serve in that capacity going forward.

In addition to my work at the Seminary I have carried out the following ministries during the past year.

On April 14, 2015, at the request of the Very Rev. Canon Dr. Jonathan S. Riches, I participated in the dialogue session between the Lutheran Church Missouri Synod and the Anglican Church in North America, hosted by Reformed Episcopal Seminary on its campus in Blue Bell, Pennsylvania.

Bishop Hicks then welcomed Bishop Murdoch, who greeted Council and gave a brief overview of his background in the faith. He recognized the great work that God was doing in North America and stated that the global nature of what God was doing in Anglicanism was exciting. He encouraged attendees to reach out in stewardship. Faith is spelled R-I-S-K. Tithe and keep tithing even when you don't think you can. God will enable when we take risks, and we give to be a blessing to God and his Church. "You will be a blessing and you will be blessed."

As Bishop Hicks offered his report, the chair was delegated to Bishop Gillin. Bishop Hicks requested that Thursday's offering be given to ARDF for South Carolina, and Friday's offering be designated for Board of Foreign Missions. A motion was made, seconded, and passed to accept the recommendations from Bishop Hicks.

Beginning his exhortation, Bishop Hicks noted that he would be speaking from the heart, in love, and may be blunt at times, but speaks out of concern for the Diocese. He acknowledged, however, that he knew he would be "speaking to the choir." Although the support has been appreciated, there are tough things that we need to think about.

First, he reminded Council that Dr. Steven Tighe, with the Young Anglicans Project, would be speaking tomorrow. Dr. Tighe will be speaking to Council about the "Engage" Program. Through this program, older parishioners mentor youth, especially in a congregation where, for various reasons, it is difficult to minister to young people. Bishop Hicks encouraged everyone to be available to hear Dr. Tighe's talk. Training for this program is scheduled for March 5, 2016, at Grace Church, Collingdale. Cost for the training will be \$25, including lunch. He encouraged at least one person from each parish to attend.

For the past several years, the ACNA bishops have been attending the March for Life on the anniversary of Roe v. Wade. The next march is scheduled for Friday, January 22. Prior to the march, there will be an Anglicans for Life Summit on January 21. The topic for this summit will be teaching parishes methods to keep issues of life on the minds of their congregations throughout the year.

Bishop Hicks stated that it has been increasingly difficult for parishes to find affordable health insurance for clergy, and clergy have approached the Bishop over the past year for advice regarding this issue. In this regard, Bishop Hicks has asked Dr. Wayne Headman, Chairman of the Ministers Salary Committee to have a report prepared for next year's Council which would

include resources, people, and material. Anyone who has information to assist Dr. Headman should pass it along to him directly.

The Bishop then offered an update on his meetings with the Holy Orders Task Force. He explained that when ACNA formed, some members came from jurisdictions which ordained women. Because of this serious difference, it was determined that members needed to find a way to come together and organize, following which the issue of ordination of women would be discussed. The Bishop was asked to chair the Task Force. They first examined hermeneutical principles, and currently are dealing with ecclesiology; next year they will be looking at arguments for and against ordination of women. Following these discussions, the Task Force will provide information to the College of Bishops and they will then begin to examine how to handle this difference of opinion. This difference of opinion will not cease once the Task Force's work is done; however, the Bishop acknowledged that both sides are committed to Jesus Christ, love the Lord and are committed to the scriptures. He asked that we pray for the Task Force to find a way forward.

The Bishop then addressed the financial issues facing the Diocese. At last year's Council we heard a very sobering report on the finances of the Diocese. The Trustees have taken the situation seriously and have been working on the problem and moving forward with solutions. Only two things can be done: either the income needs to be larger, or the expenses need to be less. Income comes from investments and parish tithes. Investments are not performing as in the past; and, although some growth has been shown, not all parishes are tithing and some are sporadic. Tithing is a spiritual principle. God is not looking for an amount of money; He is looking for a commitment, and trust that He will be faithful. The two largest expenses for the Diocese are the Bishop's salary and contributions to the Seminary. To make the Bishop part time is not a practical option. Having a full-time Bishop has been essential to the Diocese. Additionally, the Seminary has been the heart of our Diocese, and has contributed to NEMA being so strong. The Seminary is poised to do a great service to the Church.

The Bishop stated that he cannot control each parish, but can provide resources for parish growth. He noted that only half of the Diocese attended the training by Canon Ashey, and only half of the rectors attended the clergy retreat with Canon Ashey. The Bishop further stated that lack of money is only a symptom. The Bishop's prayer is that the Seminary, because of the positive movement that is taking place, would eventually be contributing to the Diocese, and not the reverse. If, however, we do not move things forward, the Diocese would be in dire straits in five years. (Further information and clarification will be presented in the Treasurer's report.)

In closing, the Bishop said that we should move forward for the sake of the Gospel. He called for vision and forward thinking, and for all to step out in faith with him. Encourage one another. We can do it. We know the right thing to do.

Jason Patterson, and the Rev. Chiron Thompson. I gave the benediction.

III. Other Activities

St. Mark's Organ Dedication. On Sunday, October 5, 2014, I attended the dedicatory service for the organ at St. Mark's, Rydal. Special recognition was given to Mr. Bernard McGorrey for overseeing the project.

St. Mark's Fellows: I have been meeting quarterly with the seminary students and postulants who are serving at St. Mark's, Rydal, and who are participating in the St. Mark's Fellows program.

Clergy & Spouses' Retreat: I attended the annual clergy and clergy wives retreat held at the Eden Resort in Lancaster, Pennsylvania, January 22-24, 2014.

Clergy Leadership Retreat. On April 30 – May 1, 2015, the Diocese sponsored a clergy leadership retreat, led by the Rev. Canon Phil Ashey. I attended the sessions and strongly encouraged all of the rectors of parishes to do the same. About a dozen clergy attended, and sadly not all the rectors of parishes were there. Another retreat is being planned for 2016.

Diocesan Youth Camp. On Friday, July 24, 2015, I visited the Diocesan Youth Camp at Rock Mountain Bible Camp, Susquehanna, Pennsylvania. Mr. Billy Jenkins continues to do outstanding work with our young people.

IV. Reformed Episcopal Seminary

Administration. I continue to serve as President and Chancellor of the Seminary and Associate Professor of Biblical Languages and Literature. The Board of Directors met on Friday, October 31, 2014 and May 15, 2015.

We have begun to use part of the new building on the seminary campus. The bookstore was moved there with the help of the summer mission team. We have received a report from a special committee that I appointed to evaluate the possible use of part of the new building by the Committee on Young People's Work. That report was received

favorably, and an office and recreation area have been designated for the COYPW. With the student population growing, we are in need of using the newly acquired space; however, until the mortgage is satisfied, we must rent most of the facility to outside businesses.

I have appointed a committee to study, evaluate and make recommendations concerning the relationship between Reformed Episcopal Seminary and the Diocese. Both the Seminary Board and the Diocesan Board of Trustees have recommended that such a study take place. I expect that the Seminary and Diocese will continue to work cooperatively in a close relationship, but more clarity is needed in regard to governance and areas of responsibility. The committee is comprised of three members from each of the respective boards.

Concordia Theological Seminary, St. Catharines, Ontario. I attended the conference on "Militant Secularism" on October 16-17, 2014, and I also participated in the dialogue meetings between the Lutheran Church Missouri Synod and the ACNA, held

there at the same time. Another round of talks was held at our Seminary on April 14-15, 2015, in which I also participated.

Kuehner Lecture: The Rev. Dr. Chad Hatfield, Chancellor of St. Vladimir's Seminary was the speaker at our annual lecture series on Tuesday, December 9, 2014. I attended the sessions and presided at Morning Prayer.

Friends of Reformed Episcopal Seminary (FORES). I attended the RES banquet on Saturday, May 30, 2015, as well as the picnic for the Seminary community on Saturday, September 20, 2014.

Commencement. On Saturday, June 6, 2015, I participated in the commencement service for the graduates of Reformed Episcopal Seminary. The service was held at St. Paul's, Oreland. The commencement speaker was the Rev. Dr. John Stephenson of Concordia Lutheran Seminary, St. Catherines, Ontario.

Diocesan Mission Project: The Diocesan Mission Project was focused upon Reformed Episcopal Seminary and St. Patrick's Fellowship, Norristown. About fifteen people spent the week of August 10th through 13th working on projects on the Seminary campus and doing street evangelism in Norristown. Deacon Roger Converse led the activity, assisted by Mr. Shawn Riley.

V. Pastoral Connections and Vacancies

St. Luke's, New Providence. St. Luke's extended a call to the Rev. Howard Currie to serve as rector. Rev. Currie was installed on Saturday, March 14, 2015.

Grace Church, Scranton. The Rev. Paul Howden resigned as rector of Grace Church, Scranton, and his responsibilities ended in December 2014. The primary reason for the resignation concerns the inability of the parish to sustain a full-time salary for a rector. In January, the parish requested to become a mission parish, and the request was granted by the Standing Committee.

I visited Grace Church several Sundays in the early part of the year, and on July 26, 2015, I called a congregational meeting to discuss the appointment the Rev. Mr. Blitz. My suggestion received unanimous approval by the members present at the meeting, and he began serving as vicar on September 1, 2015.

Bishop Cummins Church, Catonsville. The Rev. Dr. David Crum announced his retirement as rector of Bishop Cummins Church, effective the end of May. I met with the vestry of Bishop Cummins Church on Monday, March 16, 2015. The purpose of the meeting was to discuss questions and concerns the vestry had about the life of the Diocese and the REC, as well as to provide counsel for the pastoral search committee. After significant prayer and reflection, the vestry has called the Rev. Cedric R. Benner to serve as rector, and a service of institution was held on Sunday, October 18, 2015.

- **St. Luke's & Bishop Hoffman Church**, Philadelphia. Services and pastoral care at St. Luke's and Bishop Hoffman Church are being provided by the the Rev. Richard Baird and the Rev. Frank Spadafora. The Rev. Barton Craig has announced his retirement, due to health matters. Bishop Gillin and I alternate in attendance of Vestry meetings on a quarterly basis.
- **St. Timothy's Church,** Mt. Laurel. The Rev. Michael Carr has been appointed vicar of St. Timothy's. Under his leadership, the parish has moved the location for their worship services. They are now meeting at New Covenant Presbyterian Church, Mt. Laurel, New Jersey. Bishop Gillin continues to provide primary episcopal oversight of the parish.

Atonement Church, Philadelphia. The Very Rev. Walter Hawkins has resigned as vicar of Church of the Atonement, effective September 30, 2015. Dean Hawkins has communicated with me and the congregation that he believes he has prepared the congregation for the next step of their revitalization but senses that it is time for his gifts of ministry to be used elsewhere. I am deeply grateful to Rev. Hawkins for his years of sacrificial and dedicated service to Church of the Atonement. I will be taking direct oversight of the parish, until further possibilities become apparent.

St. Michael's, Enola. The parish continues to struggle, and I have appointed a provisional vestry to serve the needs of the parish.

Jesus the Good Shepherd, Brooklyn. The report of the Trustees of Diocese will include information about the sale of the church building, located on Washington Avenue, Brooklyn. The parish in unable to meet the current mortgage expenses associated with the building. It is our hope that proceeds from the sale of the building will be sufficient to include the acquisition of new, more affordable building for the parish.

Church Planting. In addition to the work, mentioned above, we continue to explore church planting efforts. The Rev. Russ Buchanan continues to work with St. Patrick's Fellowship, Norristown. St. Mark's, Rydal, Atonement Church, Philadelphia, and St. Alban's, New York, continue to explore church planting possibilities.

REPORT OF THE STANDING COMMITTEE

TO THE ONE HUNDRED AND THIRTY-FIFTH COUNCIL OF THE DIOCESE OF THE NORTHEAST AND MID-ATLANTIC OF THE REFORMED EPISCOPAL CHURCH

A meeting of the Standing Committee was held by conference call on February 17, 2015. The Rt. Rev. David L. Hicks called the meeting to order at 11:00 a.m. The following additional members were present: the Rt. Rev. R. Charles Gillin, the Very Rev. Messrs. Gregory J. Miller and Belgrave Pelle, the Rev. Cedric R. Benner and Messrs. Edward Meharg and Brian K. Davis. The Standing Committee elected the Very Rev. Gregory J. Miller as President. The Standing Committee also elected the Rev. Cedric R. Benner as Secretary.

The Standing Committee approved the request of Grace Reformed Episcopal Church in Scranton, Pa to be a mission church of our diocese.

The Standing Committee approved the name change of The First Reformed Episcopal

Church in NY to St. Alban's Anglican Church: The First Reformed Episcopal Church, NY.

REPORT OF THE SECRETARY OF THE TRUSTEES OF THE DIOCESE OF THE NORTHEAST AND MID-ATLANTIC

To the One Hundred Thirty-Fifth Council of the Diocese of the Northeast and Mid-Atlantic of the Reformed Episcopal Church

Dear Brethren,

The Board of Trustees met four times since our last report at the 134th Council of the Diocese. Trustee meetings are held at the Reformed Episcopal Seminary in Blue Bell, PA or by teleconference, with the exception of the November meeting which is held at the site of our annual Diocesan Council. Bishop Hicks has presided over all meetings of the Board of Trustees in the preceding year. Regular reports were received from the President, the Vice-President, the Treasurer, and the Provost of the Reformed Episcopal Seminary.

NOVEMBER 7, 2013: Appointment of Officers: At the annual organizational meeting of the Trustees held at Diocesan Council the following officers were elected: The Rt. Rev. David L. Hicks, President; the Rt. Rev. R. Charles Gillin, Vice President; Mr. Ron Riches, Treasurer, the Rev. Canon William A. Jenkins, Sr., Secretary.

DECEMBER 30, 2014: A teleconference meeting was called to act on the recommendations of the Special Finance Committee. This Committee had been called to review the litany of historical funds which were still segregated on our books, but may no longer serve the original purpose for which they had been designated. Any funds that were not restricted were moved into the general fund. Other funds were tabled for future discussion and the remainder were referred to continuance.

The Trustees agreed that all income from funds may be transferred at the discretion of the Bishop and Diocesan Treasurer to the General Fund unless real restrictions prohibited such moves.

Trustees agreed that all parish assistance considerations must be preceded by 3 items: Each fund involved should have an individual journal page headed by the funds restrictions and guidelines, with a listing of every financial transaction of the fund; each parish should have a journal page, listing every transaction between the diocese and the parish; parishes requesting financial assistance must present the current years' financial statement, along with the two preceding years statements.

Any parochial assistance agreement must be signed by the pastor, vestry and treasurer of the parish along with the diocesan trustees, and must include a payback schedule, and the following stipulations:

payments 90 days or more past due are delinquent, and delinquent parishes may have their financial

transactions subject to diocesan oversight, and may be subject to diocesan approval of their disbursements. Delinquent parishes are to be contacted at least monthly.

The trustees set up a Troubled Mortgage Committee to handle seriously delinquent accounts. The Committee is authorized to take whatever measures may be required to settle the accounts. The committee is composed of the Bishops, Diocesan Treasurer, the Dean of the Convocation of the troubled parish and the Diocesan Chancellor. The mortgages of Jesus the Good Shepherd and All Saints were immediately placed with the Committee.

MAY 11, 2015: The trustees met at Reformed Episcopal Seminary. Jesus the Good Shepherd has voted on an option to sell their existing property, using the proceeds to repay their indebtedness to the Diocese of approximately \$1.5-\$1.6M. This would leave them sufficient funds for reinvestment, relocation, and the continuance of the ministry. The repayment of the mortgage will be first applied against the funds borrowed from the Seminary to fund a mortgage for 1st Church, NY, of \$975K plus interest, and the remainder be returned to the Parish Development Fund.

The mortgage of All Saints Church is presently current, and there are no proceedings against them, regardless of their move away from the REC.

The Trustees voted to secure the services of Jason Grote to perform an audit for the Diocese and give us an evaluation of the endurance of our portfolio.

The trustees agreed that Bishop Gillin remain a trustee on the mortgage of 1st Church, NY, and that Mr. Ron Riches be added to fill a vacancy, and that together they work to facilitate communication and progress on the mortgage between 1st Church and the Diocesan Trustees. The Trustees agreed to hold the Seminary harmless in the event that there is not a timely payment from the 1st Church mortgage. It was also noted by Bp. Gillin and Rev. Matthew Harrington that 1st Church has set up an automated withdrawal system for payments going forward, beginning with the 15 of May, 2015. Progress is also being made on keeping 2 months payments in escrow as initially required.

A new set of policies and procedures were approved for financial transactions and mail distribution at the Diocesan Office and Seminary.

SEPTEMBER 14, 2015 The annual Diocesan Budget for 2016 was proposed, reviewed, amended, and approved for adoption by the 135th Council of the Diocese of the Northeast and Mid-Atlantic of the Reformed Episcopal Church.

Bishop Hicks called for a reading of each individual parish and their tithe submissions. It was noted that several churches had sent nothing, and that others were plainly sub par.

Consideration was given to our portfolio performance, with professional money managers making several helpful suggestions to increase performance over time. A committee is being

assembled to create strategic planning implementation to address the on-going deficit in our budget.

Greetings were then offered by Bishop Grote, who spoke of the great nostalgia he was feeling, as St. Paul's was the place where he was first introduced to the Reformed Episcopal Church. While he was listening to Bishop Hicks speak, Bishop Grote was reminded of Psalm 124: "If it had not been the Lord who was on our side, Now may Israel say if it had not been the Lord who was on our side when men rose up against us, then they had swallowed us up quick when their wrath was kindled against us, then the waters had overwhelmed us and the stream had gone over our soul, and then the proud waters had gone over our soul. Blessed be the Lord who has not given us as prey to their teeth." This is important to consider when we have to think of the realty of the times. If the Lord had not been with us, then we would have been consumed; but, in 143 years of history of the REC, we have not. He will be here until Christ returns, all we have to do is be faithful and take the necessary steps and trust in the Lord. We must continue to move forward in ministry and continue to proclaim the Good News. In spite of difficulties, there is movement in a positive direction. In 1972, there were 64 congregations. There are now200 Reformed Episcopal Churches around the world: 28 congregations in Cuba, 14 in Europe, Germany and Croatia, 25 congregations in England. He charged delegates to go home and share with others what they had heard and experienced during the meetings.

The Treasurer's Report followed Bishop Grote's greetings.

Treasurer Mr. Ronald Riches began his report by saying that he wanted to focus on where we are going; not where we have been. We are deficit spending. It is not sustainable; however, there are ways to reverse it and that is what we should focus on. He pointed out that investments are not performing, and we are withdrawing from investments to pay bills. On average, parish tithes are down 3%. Expenditures have risen 3%. The trend over the past few years has been dramatic. Our annual revenue is less than half of our expenditures. Part of the solution is to cut expenses and increase income. Mr. Riches also stated that we need to minimize our cash position and try to put cash back into investments that are growth oriented. He added that resources need to be moved out of mortgages and back into investments. External consultants have been asked to look at our investments and advise.

In addition, Mr. Riches advised that the way in which tithes are approached in parishes makes a huge difference. Guidelines will be revised as of January 1, 2016. Discussion ensued during which Mr. Riches clarified some of the specifics of tithing. Bishop Hicks interjected that Rev. Andrade's church wanted to be an example to other churches and gave a gift to the Diocese and Seminary, over and above their regular tithe. Bishop Hicks thanked them publicly, and noted that giving and wanting to give freely is part of being a Christian.

A motion was made to accept the Treasurer's Report. The motion was seconded by Dr. Riches and passed.

REPORT OF THE TREASURER OF THE BOARD OF TRUSTEES

To the One Hundred Thirty Fifth Council Of the Diocese of the Northeast and Mid-Atlantic Of the Reformed Episcopal Church

Dear Brethren,

NEMA's current financial situation presents significant challenges. In our present situation, deficit spending continues and it is unsustainable. Current assets in checking and investment accounts are a shrinking source of funding. Meaningful planning for ministries and operation in the future is made difficult. This report presents current financial status, the challenges it presents and a summary of actions planned to resolve major contributing issues. A defined course of action and measurement is necessary to avoid the insolvency that is likely in five to ten years time if we were to allow the current financial situation to continue unchecked. Financial actions to be taken will be part of an overall NEMA strategic plan that the NEMA Board of Trustees has directed to be undertaken. Accordingly, the focus of this report is on the future and preparing for it, the past being addressed only so far as is needed to identify things on which to capitalize and things to avoid in the future.

Account Summary

A summary description of the accounts whose status is presented herein is available in Appendix I of this report.

Financial Reports (audited) – Statement of Activities & Statement of Financial Position for Year-Ending (YE) 2013 & 2014 and 2015 Year-to-Date (YTD) September 30, 2015

These reports are available in Appendix II of this report. There are several key points for the reporting period:

In the Statement of Activities;

- † Total revenue was down 22% from 2013 to 2014 and has fallen sharply in 2015 led by a decline in revenue from investments, largely due to a combination of market performance and withdrawals to fund diocesan expenditures. Contributions by parishes ("Parish Tithes") are in steady decline at about a rate of approximately 3% per year
- † Overall expenditures have increased at an annual rate of 3% except during 2015 as it became necessary to advance regular disbursements to RES by one month to maintain positive cash flow

† Expenditures are currently exceeding revenue by \$227,326.

In the Statement of Financial Position – 2013 to 2014;

- † The cash position rose 23% or \$39,900 in 2014 due largely to the sale of the St. Philip's property
- † Investments have declined by 13% or \$183,700 due largely to withdrawals for deposit in operating cash accounts although negative market performance during the third quarter of 2015 has been a significant negative contributor;
- † Mortgage receivables were up 19% or \$315,100 largely due to the sale and subsequent take-back mortgage of the St. Philip's property
- † A significant portion of our Fidelity investments are restricted in the way that they can be used. Included are all of the Benson Fund (\$138,978) and a portion of the Diocesan Investment Account. The latter is estimated to be \$152,458, which amount has been reported in recent history as comprising the Cape St. Clair Fund. The actual amount and the donor's intentions remain in question and the work to resolve the matter is continuing.

Summary of Current Assets

The chart in Figure 1 documents our current assets as of September 30, 2015. Data begins with that provided in the audited reports. The mortgage receivable amount of \$975,000 for First Church, NY, has been added to this summary as both an asset and a liability. This is because the mortgage note is held by the Diocese but is funded by RES. Loan payments are currently "interest only" and that interest is currently being paid to RES. Current interest payments are not accounted as revenue to NEMA.

The assets of immediate concern are: the Diocesan Checking account – used to receive funds from various revenue sources and make disbursements to meet expenses for diocesan ministries, programs and operation; and the Fidelity Diocesan Investment account – used to fund the Diocesan Checking account to the extent that primary revenue sources are unable to fund necessary disbursements. A Statement of Receipts & Disbursements for the Diocesan Checking Account for 2014 and 2015 September 30 YTD is available in Appendix III of this report. Financial performance and trends, which constitute deficit spending, that are evident in 2014 have clearly continued to date during 2015.

ISSUES & ACTIONS

There are really only three ways to end deficit spending – increase revenue, decrease expenses or both. In general, revenue needs to be the focus. It's not possible to save your way to solvency. If expenses are cut to the extreme, the entity that incurs them in order to operate must cease to exist. Revenue that is insufficient to meet expenses will achieve the same end. Both must be addressed together.

NEMA's challenges in the area of revenue are twofold; investment income and contributions from parishes.

Revenue – Investment Income

Too much of our capital is invested in mortgages where returns are earned at a fixed rate, at best. Capital invested in mortgages is not readily available for directly meeting expenses or for investment in instruments that historically provide higher returns. Focus is on income and not growth, the present and not the future. Our mortgage receivables have grown to the extent to which has resulted in lost opportunity to gain from investments made in instruments with higher returns. It has also strained our reserves held in cash and investment accounts.

Our Fidelity Diocesan Investment Account has lost 29% of its value throughout the reporting period. A substantial cause is the increasing rate of withdrawals, which not only depletes the cash in the account but results in the same effect of lost opportunity as does our mortgage receivables position. Major factors contributing to the decline in the account's value include weak market performance and an investment strategy that trends toward capital preservation and income rather than capital preservation and growth.

Based on these parameters and reviews by independent financial advisors, a new investment strategy is needed and will be implemented as approved by NEMA Trustees as part of the strategic planning program that they have directed. Key elements of the strategy generally will be: to convert investment assets currently held in mortgages to other asset classes; to transition from income-oriented to a growth-oriented investment model.

These are improvements that can be made by the Trustees where practical while the diocesan strategic plan is being formulated, thereby avoiding delay of potential benefits that could result from our investment strategy. At the same time, we will manage the investment's cash position such that capital is held as long as possible for investment before being converted to cash to meet expenses.

Revenue – Parish Tithes

Revenue received in "Parish Tithes" continues a downward trend. A report of receipts in "Parish Tithes" YTD September 30, 2015, is available in Appendix IV of this report. A brief analysis of data submitted by parishes for 2010 through 2014 using the NEMA State of the Diocese survey process reveals the state of the matter.

There are many parishes that have not tithed during the period.

Chart titled Four Year History of Parish Tithing

This situation has worsened during the period.

Chart titled Parish Contribution at Percent of Income

The situation has resulted in the loss of \$258,000 in revenue to the Diocese during the reporting period. The contribution to the 4-year loss has been significant by some individual parishes.

Chart titled Parish Contribution to Total Diocesan Revenue Loss

There is no action that the NEMA Trustees can take to address this matter except for measurement and timely reporting of parish contributions to the Diocese. That practice will continue on a regular basis.

Expenses

There is virtually no opportunity to limit expenditures without discontinuing some ministries, programs and/or operation. This fact becomes evident when comparing YE 2014 and YTD 2015 financial performance and using these to produce a budget for 2016.

PROPOSED BUDGET FOR 2016

Appendix V of this report presents the 2016 budget as proposed by the NEMA Trustees for approval by the 135th NEMA Diocesan Council.

RECOMMENDATION: The NEMA Trustees recommend approval of the 2016 NEMA budget as documented in Appendix V of this report.

Transition to Paperless Financials

Significant reduction in the amount of paper used to manage the finances of our diocese could result in corresponding savings of time and expense. Paper requires a large amount of storage space, which is becoming increasingly expensive. Staff time and effort to search for and retrieve data and information is even more expensive and limited in capability compared to high-speed electronic search and retrieval. Detailed documentation of financial transactions can be stored electronically with the transaction itself in the financial software system's data base. The audit for this period has been conducted without the expense of travel or exchanging paper media, everything being accomplished electronically. And we're not being pioneers in this effort. Financial institutions, suppliers, service providers and others have been operating this way for many years and electronic format of what has historically been in paper format is now fully legal and accepted. Indeed, we may not have a "paper choice" available for many financial transactions in the not-so-distant future. In preparation for the inevitable and to begin to now realize some of the economic benefits of paperless transactions, the following policy for regular NEMA payments to parishes or individuals will become effective January 1, 2016. This policy extends and formalizes the practice established during 2015 for the REC's retired Presiding Bishop, NEMA's bishops, the Reformed Episcopal Seminary and the Trustees of the Sustentation Fund of the Reformed Episcopal Church.

The scope of this policy is for regularly scheduled, e.g., monthly and quarterly, payments by NEMA. All such payments to individuals or parishes will be made only by direct deposit to the appropriate account. Approval and authorization for NEMA to use an account for direct deposit is to be provided *in writing* by the individual or, in the case of a parish, by the parish rector and wardens, directly to the attention of the NEMA Treasurer at the Blue Bell HQ address. Attendant with such approval, and in documentation of such for the use of NEMA's Treasurer and future staff, must be a voided check against the account which is to receive the direct deposit.

APPENDIX I

Summary of Accounts

The diocesan financial accounts consist of three (3) checking accounts and three (3) investment accounts. In 2013, the Univest Checking account was closed into the main checking account.

Checking Account Summary

The checking accounts for the Diocese are as follows:

- 1. The Diocesan Checking account is effectively the general operating account for the diocese. It is a Wells Fargo checking account. This account handles the normal accounting activities of the diocese. This account receives the income from Parish Tithes and Investment Fund Transfers and disburses payments to meet the obligations of the Diocese.
- 2. The Diocesan Escrow account is also a Well's Fargo account which is largely inactive. The intent and use of this fund is to be better defined but reportedly has some relationship to Jesus the Good Shepherd Church.
- 3. The St. Philip's account is a Well's Fargo account formed as a result of the rental and sale of the former St. Philip's church. This account is now designated as the bishop's discretionary account from which disbursements are authorized jointly by the bishops and treasurer.

Investment Account Summary

The investment accounts for the Diocese are as follows:

1. The Diocesan Investment account is often referred to as the 4.0 account. Financial accounts for the diocese have evolved over time and various funds have been consolidated into this common, co-mingled account. This account is currently being used as a source of income to meet the obligations of the Diocese. This fund contains restricted funds and non-restricted funds. There is no documentation presently available that accurately defines what is restricted, the only reference to restricted funds being one that historically appears in NEMA Treasurer reports. This reference is to a fund titled the Cape St. Clair Fund, which contains the proceeds of the sale of a

property in Baltimore that was donated to the Diocese. A review of historical information is being conducted to re-establish the intent of the donor. It is important to retain, where possible, restricted accounts. This account also includes a mortgage for All Saints Anglican Church, Newark, NJ.

- 2. The Parish Development account is often referred to as the 4.3 account and is a non-restricted account. This account had been used to fund general obligations of the Diocese until the May 2014 meeting of the NEMA Trustees, at which point the use of the fund for those purposes was discontinued. This account also includes a mortgage for Jesus the Good Shepherd Church, Brooklyn, NY.
 - 3. The Benson Fund is often referred to as the 4.4 account and is a dedicated fund for Grace Church, Collingdale. It is administered jointly by Bill Kozma and the NEMA Treasurer.

The Current State of Calculating & Reporting Parish Tithes

Analysis of and questions about the report of State of the Diocese data submitted by NEMA parishes for the years 2010 through 2013 and quoted in the NEMA Treasurer's Report have highlighted variations in reported parish tithes as a percentage of total parish income. Variations appear in some instances from year to year and from parish to parish. Measurement and reporting of parish tithe income to the Diocese is skewed by these variations. The financial impact to the Diocese of lost revenue from parish tithes during the years 2010 through 2013 has been measured at \$258,000. The absence of specific, commonly understood guidelines, measurement and reporting processes, uniformly applied, will yield results that are approximations at best. Such is the case with the charts and graphs in this year's Treasurer's Report that address parish tithes.

A resolution to the situation is not readily achievable. Thoughtful consideration of multiple parameters is required in order to establish a reasonable long-term policy for parish tithe guidelines, measurement and reporting. The NEMA Strategic Plan directed by the NEMA Trustees needs to produce such a resolution. In the meantime, it is recommended that the following guidelines be applied beginning January 1, 2016:

1. Amounts to be included in parish tithe calculations are:

- 1. All amounts received into an operating account for unrestricted use e.g., pledge, plate, undesignated contributions, rental income from non-REC sources, proceeds received from parochial school operation (the latter being a change in policy);
- 2. Income to an investment and/or savings account or fund whose purpose is to fund any operating (unrestricted use) account e.g., dividends, interest, realized gains;
- 3. Amounts transferred from unrestricted investment and savings accounts or funds to operating accounts when such amounts had not previously been included in tithe calculations e.g., restricted accounts or funds that have newly been made unrestricted.

2. Regular periodic measurement and reporting

This task will be undertaken by the NEMA Treasurer, results being distributed to parishes and NEMA Trustees. Forms used to collect data from parishes for the purpose of defining or reporting parish income and tithes will be made consistent with each other and the recommended guidelines. A new Parochial Apportionment form will be available via the Diocesan Website in time for parishes to use beginning in January 2016. A new State of the Diocese survey form and report will be available for the 2015 survey, planned to be coincident with the ACNA Congregational Reporting process early in 2016. The NEMA Treasurer will be available to help parishes in their task of qualifying parish revenue into the appropriate category.

Following the Treasurer's Report there was a 15 minute break, after which The Rev. John Smith, Dean of Eastern Canadian Convocation, offered prayer for the next portion of Council. Bishop Hicks commented that St. George's congregation are a loving and giving people, with a strong ministry to international students.

The Rev. Gerald McLynn reported for the Nominating Committee. He pointed out that elections are now made on a three year cycle, and names are acquired through a letter of request sent out to the Diocese. Anyone who would like to make a suggestion should notify their rector, who can pass along the name to Rev. McLynn or any member of the Committee. Dr. Riches moved that the Secretary cast a single ballot to accept the slate. The motion was seconded by Mr. Ron Riches, and passed.

Bishop Hicks then invited Dr. Riches to present the report of the Dean of the Seminary. Dr. Riches began his report by saying that there are exciting things happening at the Seminary. The Seminary is rooted in Scripture, has solid academic footing, and worship is central to Seminary life. He pointed out the ecclesiastical diversity of the Seminary. In addition, he stated that the accreditation process actually started over 20 years ago because the need was there. The Seminary wants to train people to lead churches, plant churches and to enable people to learn about Jesus Christ and better serve God. The Seminary is getting more students, is approved for federal student loans, and has acquired the new building; but, it also needs more housing for students, visiting professors, and youth ministry. He also noted that the SEFY (Spiritual and Education Formation for Youth) program has been started, which offers two pre-seminary courses per year for high school and college age. The courses offered this year were Church History and Leadership, and Dealing with Conflict. Dr. Riches also reported that the Board had approved the Seminary to pursue giving a Master of Arts in Religion.

Dr. Riches thanked the Diocese for the continued support and mentioned ways in which individuals and parishes could support the Seminary: The blue piggy banks, endowment funds (The Bishop Leonard W. Riches Chair in Anglican Theology), buy bricks for the Seminary patio, the scholarship funds (St. Alban's Scholarship and the Rev. Walter Truesdale Scholarship).

Seminary students Ricky McCarl and Tom Guerra spoke about their experiences as students of the Seminary. Bishop Riches spoke briefly of his love of the Seminary, and led the Seminary Grace.

Bishop Hicks thanked Bishop Riches for his service on the Board of the Seminary and his devotion to the Reformed Episcopal Church, spanning more than 50 years.

Report of the Dean of Reformed Episcopal Seminary

To the One Hundred Thirty-fifth Council of the Diocese of the Northeast and Mid Atlantic

Dear Brethren:

Reformed Episcopal Seminary (RES) continues to understand its ministry and mission to be integrally connected to the mission of not only the Diocese of the Northeast and Mid-Atlantic and the whole Reformed Episcopal Church and the Anglican Church in North America, but also to other orthodox Anglican jurisdictions, the wider Christian church and our communities. The Seminary's mission is "to train Christ's people to serve the flock of the Lord Jesus Christ through Biblical, Anglican Worship, Example, and Discipleship as defined in the official standards of the Reformed Episcopal Church and the Anglican Church in North America. Students are immersed in Scripture, the historical and ancient traditions of the church, worship, and doctrine. Emphasis is placed on classical Anglicanism lived out in the world through worship, evangelism, and discipleship." In its history RES has served students from every Diocese of the Reformed Episcopal Church. Currently RES is serving three students from our Diocese, one from the Diocese of the Central States, one from the Diocese of Mid-America, and one from the Diocese of the West. RES students have also come from various ACNA dioceses including CANA East, the Diocese of Mid-Atlantic, PEAR, the Diocese of San Joaquin, and the Anglican Diocese of the South. We have a growing number of students from the Anglican Province of America. Our diverse environment also includes a significant number of students from other traditions, including United Church of Christ, Baptist, Presbyterian, Pentecostal, nondenominational, Reformed Baptist, and Christian Missionary Alliance. RES is also blessed with a racially diverse student body. Students of various traditions and backgrounds study and worship together, learning both to defend the faith and also to relate better to others with different perspectives.

In addition to training adults in its graduate program, RES has since its early years placed a high priority on giving a firm grounding to youth and laity for ministry and service to the church. Seminary training includes essential foundations in theology and Scripture that are important for Christian life and service. The Seminary currently is meeting this need through the

Spiritual and Education For Youth program (SEFY). Twice a year a weekend-long pre-seminary course is offered on campus for teen and college age youth. These courses cover both foundational and practical issues of faith and are taught by Seminary faculty and staff. The next course is November 13-14, 2015 and is "Peacemaking: Resolving Conflict without Compromising the Faith." The Seminary and Diocese are furthering this commitment and priority of ministry to youth as a portion of the facility at 831 Dekalb Pike, our Professional Building, is being dedicated to an office and recreation room to be used by the Committee on Young People's Work (COYPW). It is hoped that long-term, a housing wing will be developed in this building for the use of youth programs as well as Seminary lodging.

The unprecedented growth at the Seminary has necessitated our use of the new building as more classroom and study space was needed. A new classroom, study area, lounge, recreation room, and office for the COYPW will be ready for the start of Advent Quarter at the end of November. The new book store with much more space to browse books and resources opened at the beginning of this academic year. Much other work continues to be done to improve the Seminary. RES has recently been approved to offer financial aid, which has also allowed fulltime students to defer their undergraduate loans when necessary. We are working on approvals to admit international students again as there is a great demand for training from students and churches from other parts of the world. Improvements continue to be done in the areas of assessment, housing, fundraising and development, and communications. The opportunities and challenges before the Church and the Seminary require more resources including the continued expansion of our staff and faculty. At present, technically, I am the only person who works fulltime for the Seminary. The Seminary facility itself functions not only as the Seminary, but also as the Diocesan center and headquarters. One of the strengths of the Seminary it is that it is a Seminary of and for the church. Integrity and proper order and governance also demand that the resources, functions, and roles of the Diocese and the Seminary be properly delineated. These issues of governance will be addressed by the Seminary Board and the Diocesan Trustees in the coming years in accordance with the canons and the standards of the Association of Theological Schools. In order to better serve the Seminary, and in turn the Diocese, I have resigned from the Trustees of the Diocese after sixteen full years of service. Of course, I will continue to be very involved in the life of the Diocese as a clergyman and the Canon Theologian. In terms of administration and governance, my focus is entirely on the Seminary and the theological training of people for the ministry.

We have completed three years of successful audits according to Generally Accepted Accounting Principles (GAAP) and now meet government auditing standards. The summary of the last audited financial statements has been provided to the Council. Our yearly audits are presented to the Board of Directors which also approves our budget.

While there is a lot of work to be done, this is an exciting time in the life of the Seminary. There are many activities which are on-going. Classes once again meet five days a week. We will have a new March term beginning in 2016 which will feature short-term mission training offered through the Society of Anglican Missionaries and Senders. This will be structured so that people can register just for the training or for a class for academic credit which includes the training. Our summer intensive courses continue with a Youth Ministry course this summer connected with the Diocesan camping ministry. We continue to see a significant increase in admissions inquiries and visits. We have monthly Convocations which are open to the public in which faculty and special guests shared their research and insights to further the work of the ministry. We are scheduling visits from bishops from throughout the Anglican Church in North

America and other Anglican jurisdictions which we serve so that our students and local pastors can learn and grow from the experience of the church in other areas. In 2016 Bishop Bill Murdoch from the Diocese of New England will be joining us as will Bishop Jack Iker from the Diocese of Fort Worth. We have been in contact with Archbishop Foley Beach and are working on a date for his visit as well.

Please pray fervently for the mission of the church and the Seminary. We continue to need your referrals. We need more men and women from throughout the Reformed Episcopal Church and the Anglican Church in North America to study at RES and be prepared to better serve the church and the communities where they have been called. RES continues to appreciate the added space that the purchase of the property at 831 DeKalb Pike has given us. Increased parking is greatly appreciated, especially on days when there are special events, Diocesan Committee meetings, or guests. The yearly picnic sponsored by the Friends of Reformed Episcopal Seminary on the expanded campus grounds has been greatly appreciated by students, alumni, staff, faculty and their families. The new building is providing us space for youth functions, but also much needed office, bookstore and classroom space. Thank God with us for his provision. We eventually hope to have better facilities and technology so that classes can be broadcast to other locations including our parishes for enrichment, for continuing education, and for credit.

Reformed Episcopal Seminary continues to need your prayers and financial support both for our general operating budget and the Building for the Future Campaign, which is designed to help us meet many of the challenges facing our church today. RES provides not only a solid education rooted in the Anglican tradition guided by our bishop, it provides students from our church, the community, and the wider church with day-today mentoring and formation need for pastoral skills and the spiritual formation of others. This is not something that can be taught to the same degree in the on-line courses and modular formats that are becoming increasingly prevalent today. Further, RES provides supervised ministry experiences for students both as part of the Seminary curriculum and through churches in our diocese and community. This experience is extremely important in the formation of clerical and lay leaders for the years to come. Please prayerfully consider how you can support the Seminary in the important goals that have been set before us. Please ask your vestries and church members to do the same. We know that almost every church and household budget is tight. The Seminary has had and will have an important role in the formation of our diocese, church, and community, and has an expanding role that is worthy of your prayer and support.

At the same time the Seminary understands that it is an agency of the Diocese and the Church. We exist for the students that we train, for our churches, and our young people. Please do not hesitate to tell us what you need from us and how we can better serve you and your church. Many of the ideas that are part of the current vision have come from those currently in the pew and behind the pulpit. We again cherish your ideas and prayers. They are an essential part of our communal life together as the body of Christ.

The Board and administration of the Seminary has many important issues to grapple with as they lead the Seminary into the future. The Seminary's structure and function, development, and direction all need to be properly assessed and continually improved. Additional degree program and training options need to be assessed and considered. Please pray for God's leading on these issues and all aspects of the life of the Seminary that we may always better serve him and his people.

If anyone would like to meet with me to discuss the ministry and mission of our

Seminary I remain more than happy to set up an appointment with you or to visit your parish and present the work of the Seminary. Please stop by our table.

In all these things and many others, I with the rest of the faculty and staff continue to be "Ambitious to be well-pleasing unto Him."

The Board of Examining Chaplains this past year consisted of the Rt. Rev. David L. Hicks, the Rev. Michael D. Firzpatrick, The Very Rev. Walter L. Hawkins, the Rev. Canon Dr. Jonathan S. Riches, the Adjunct members included the Rev. Cedric R. Benner, Deaconess Ruth Cresswell, and the Ven. John R. Smith.

The Board serves as the advisor to the bishop with regards to the examination process for candidates for ordination or transfer to the offices of permanent deacon, transitional deacon, and presbyter, as well as for candidates for the office of deaconess. We continue to work closely with Reformed Episcopal Seminary to ensure that the academic requirements for the candidates for each of these offices are met in the Licentiate and Master of Divinity programs. The Masters of Divinity program at Reformed Episcopal Seminary is the normative path for preparation for Ordination in this Diocese. Those who have not completed their education at Reformed Episcopal Seminary are required to pursue at least a Certificate in Anglican Studies at the Seminary. Situations are discussed on a case by case basis based on the standard requirement for each office in accordance with the canons.

In general candidates are given a study guide and when they are ready and schedule a time for a proctored exam in which they have access to nothing but a laptop and write on examination questions assigned by the committee. The Rt. Rev. David L. Hicks and the Rev. Canon Dr. Jonathan S. Riches are the members of the committee that select these exam questions and make arrangements for the administration of the written exams. The written exam is read by all of the examining chaplains who give comments to each other or through the Bishop. An oral exam is then scheduled with usually at least three examining chaplains participating.

During this Diocesan year seven examinations will have been conducted:

- 1. On Wednesday, October 1, 2014, Jason Holloway was examined for ordination to the presbyterate. The examiners were the Rt. Rev. David L. Hicks, the Rev. Cedric Benner, the Very Rev. Walter Hawkins, and the Very Rev. Dr. Jonathan Riches. The examination was sustained.
- 2. On Monday, February 9, 2015, Howard Currie was examined for reception from the Orthodox Presbyterian Church.. The examiners were the Rt. Rev. David L. Hicks, the Rev. Michael D. Fitzpatrick, and the Rev. Canon Dr. Jonathan S. Riches. The examination was sustained.
- 3. On Wednesday, March 4, 2015, William Vowles was examined for ordination to the diaconate. The examiners were the Rt. Rev. David L. Hicks, the Rev. Cedric Benner, the Very Rev. Walter Hawkins, and the Rev. Canon Dr. Jonathan Riches. The examination was sustained.
- 4. On Friday, May 8, 2015, Russell Buchanan was examined for ordination to the presbyterate. The examiners were the Rt. Rev. David L. Hicks, with the endorsement of the Very Rev. Walter Hawkins, and the Rev. Canon Dr. Jonathan S. Riches. The examination was sustained.
- 5. On Friday, May 8, 2015, David France was examined for ordination to the diaconate. The examiners were the Rt. Rev. David L. Hicks, with the endorsement of the Very Rev. Walter Hawkins, and the Rev. Canon Dr. Jonathan S. Riches. The examination was sustained.
 - 6. On Wednesday, October 14, 2015, Larry Spears was examined for ordination to the diaconate. The examiners were the Rt. Rev. David L. Hicks, the Rev. Michael D, Fitzpatrick, Very Rev. Walter Hawkins, and the Rev. Canon Dr. Jonathan S. Riches. The examination was sustained.
 - 7. On Monday October 26, 2015, Shawn Riley is scheduled to be examined for ordination to the diaconate. The examiners will include the Rt. Rev. David L. Hicks and the Rev. Canon Dr. Jonathan S. Riches

The mandate of this committee is to find, examine, and discuss materials that would help nurture the children of this Diocese. It has indeed been a long time since we developed our own educational materials. For the time, the task of gathering available lessons and curriculum that upholds and/or reflects the "Anglican Way", and is practical and affordable, seems a reasonable goal.

Over the past few years we have discovered that publishing companies have moved, for the most part, away from curriculum based on the Annual liturgical calendar. We have also observed that many of the educational leaders in this Diocese choose instructional materials based on the particular emphasis and needs of their specific situations. Most, it seems, would not be interested in a "one-size-fits-all" approach, and presently embrace and enjoy flexibility.

There is, however, one group, to my knowledge, that is developing a curriculum based on the 1928 BCP. That group is the Prayer Book Society. This may, when completed, be of interest to some of the Parishes in our Diocese. We'll keep our eyes and ears open.

I thank the members of this committee for their willingness to serve.

REPORT FOR THE COMMITTEE ON YOUNG PEOPLE'S WORK

Dear Brethren,

The COYPW is pleased to announce the completion of a fruitful year of ministry. Our winter and summer camps were well attended, the Bible lessons at each were well received, friendships were formed and rekindled, and, in general, spiritual growth was fostered. This camping season was special for a couple of reasons. First, the speaker at our winter camp in March was the Rev. Jason Holloway. While he is anything but a stranger to the diocesan

camping program, winter camp marked his first time leading the retreat as speaker. His lessons explored the topic "Words Matter". Campers were reminded of the Scripture's injunctions against lying, gossip, and other sins of the tongue, while being encouraged to use their words for building others up and specifically for evangelism. Many thanks to the Rev. Holloway!

The diocesan Canons, Jenkins and Riches, tag-teamed as speakers for summer camp for the second straight year. Both men discussed the topic of missions. These lessons flowed right out of Rev. Holloway's call a few months earlier that our voices ought to be used for more holy purposes. Even though our speakers did a wonderful job on their own, they were complemented by those who are doing the work of foreign missions. We were pleased to receive visits via Skype from Bishop Jasmic Milic in Croatia and Matt Colvin in the Phillpines. Further, we had visits from one of our diocesan short-term mission's experts, the Rev. Jerry McLynn who spoke primarily of his work in Nepal. Lastly, we had a representative from the Eugene Bell foundation, an organization that has worked quite effectively for the eradication of Tuberculosis in North Korea. While all of our speakers were received well, it was quite clear that Tom Parsley from Eugene Bell had made a significant impact on his listeners. All six men were integral to conveying the importance of domestic and foreign missions and the committee thanks them for all their efforts.

This year also saw the launch of SEFY (Spiritual Education and Formation for Youth), a joint venture between Reformed Episcopal Seminary and the COYPW. The idea is to host two lock-in style retreats at the seminary for those in high-school, college, or of young career age. The purpose of these, as the name indicates, is to provide basic theological education which fosters the formation of the soul in Christian virtue. Our inaugural retreat focused on the broad theme of church history and how it is that the Church is One, Holy, Catholic, and Apostolic. Our next retreat takes place at the seminary November 13th-14th. The deadline for registration is Nov. 9th. The theme for the weekend is "Peacemaking: Handling Conflict without Fighting Back or Running Away". Aside from the officially stated purpose, we do hope that these retreats will, in the long run, lead to higher enrollment at the seminary and vocations for the Church.

Please look for information on Winter Camp 2016 over the Thanksgiving holiday. Forms and flyers will be sent via email to your parish. In February, you will receive information on Summer Camp including our pre-summer camp retreat for youth leaders. In addition to advertising, please keep the COYPW in prayer as we begin another year of ministry. The themes for our two camps have already been chosen and we are excited to announce that Winter Camp will focus on the last words of some of our Lord's martyrs. Summer camp will build on this topic by broadly considering the "Heroes of the Bible". Pray that the Spirit of God will work in mighty ways that the children of our diocese will be inspired to do great things for the advancement of the Kingdom.

The principal purpose of the Looney-Hoffman Fund is to make appropriations in the form of nominal interest loans for the establishment and expansion of Reformed Episcopal churches in Pennsylvania. Those "church loans", which must be secured by first mortgages on real estate, are made from the Fund's accumulated income. The total of the appropriations outstanding at May 31, 2015 was \$1,806,798.30.

The Fund manages its principal and accumulated income in a variety of investments. At year end, \$965,585.98 of that was in interest bearing loans to Reformed Episcopal organizations. The rest (\$2,858,664.07) is invested conventionally, in other mortgages, mutual funds and bank deposits.

A summary of the financial report of the Looney-Hoffman Fund for its fiscal year June 1, 2014 to May 31, 2015 is attached.

REPORT OF THE COMMITTEE ON PUBLIC RELATIONS

To the One Hundredth and Thirty Fifth Council Of the Diocese of the Northeast and Mid-Atlantic Of the Reformed Episcopal Church

Brethren:

The purview of the Committee on Public Relations is to uphold and improve the visibility and positive image of the Diocese, its parishes and the greater Reformed Episcopal Church in the eyes of the general public. The two most prominent venues of dissemination of that image at this time are via the internet and the mass media. Our primary means of posting information about ourselves is on our Diocesan website, at www.REC-NEMA.org. Our front-page blog lists upcoming events, articles of general interest, and milestones of our diocesan parishes. There are also pages of historical information, such as past Councils, and documents of common interest such as our current Constitution and Canons. Most important are the links to our member parishes and sister Dioceses, as well as other ministries and bodies within the R.E. Church such as our Seminary.

Regular update of content is our greatest struggle – a website is of more interest if it is kept current, and only a few parishes send in newsletters or notices of events. Some other items are gleaned by regular review of parish websites and interactions with other sources. Of particular interest as the renewal of the liturgical season approaches, special-focus webpages for Christmas and Easter parish events highlight services and draw visitors by improving our Google rankings via cross-links. Delegates are requested to remind their parishes of the need for website updates and the value of communicating ongoing events to the Diocesan Office.

In reviewing our parish websites for this annual report, it is disheartening to report that of our current 28 churches only two websites have been updated in the last year, while three others have gone offline for various reasons. Four parishes rely on a page on the Diocesan site, while three others use their Facebook page as their primary website. Posting updates on your church website or Facebook page is the primary means you have of increasing your own search rankings, and also makes your site more interesting for visitors. During the summer Google changed the way it does search rankings, elevating the flexibility of websites for display on mobile devices (smartphones and tablets) as a more important criteria for higher rank. Older, static websites will not do as well in searches now, while those based on web content management packages with mobile-friendly updates will do better.

Has your church considered a Crisis Management Plan? Crises come in many different natures –

natural disasters (like in South Carolina recently), sudden loss of a key leadership person, attack on or theft from the building, or more insidious ones such as embezzlement or abuse of children under care. Research on recent crises that have seriously affected churches reveals that some basic, wise preparation beforehand is the single greatest effect we can make on the outcome of a church crisis. Laying out a communication plan with multiple channels is the most important preparation an organization needs to make. Leadership, employees, church members, family members, and the neighboring community need to be informed of what happened, what is being done to address the problem, and how things will move forward. Please let the Diocesan Office know if you have a crisis or need help putting together a Crisis Management Plan for your parish.

Upon request of the Bishop and the Treasurer of the Diocese of the Northeast & Mid-Atlantic (NEMA), I have performed an audit to assist you with respect to the accounting records of NEMA for calendar years 2013 and 2014. While implementing some of the same standards and procedures, the term "audit" is defined internally and does not correspond to the definition and/or full standards of Generally Accepted Auditing Standards.

In the process of this audit and because of the transition of the treasurer responsibilities between individuals from 2013 to 2014 and again from 2014 to 2015, I chose to review the entire general ledger contained within the accounting software during this period and to provide an amended and compiled Statement of Financial Position and a Statement of Activities for the periods of 2013, 2014, and year-to-date 2015 as of September 30.

These financial statements are produced based on that information provided to me in the course of the audit. Had I performed additional procedures and been provided further information, other matters could have come to my attention which could change such reports.

The compiled statements are a part of my report and have been provided to the Treasurer of the Diocese. In summary, the reconciled cash/investment assets of the Diocese as of December 31, 2014 are as follows:

REPORT OF THE COMMITTEE ON SHORT-TERM MISSIONS

Dear Brethren:

As it is the objective of this committee to develop and implement short-term missions work and fellowship within our diocese, this year we focused our attention on the building and grounds of the Reformed Episcopal Seminary in Blue Bell, Pennsylvania. In addition, a contingent of the mission team went to Norristown Pennsylvania to assist the Rev. Russ Buchanan in neighborhood outreach. Rev. Buchanan has begun a church plant project there called St. Patrick's Anglican Church.

The project duration was August 10 to 14. Volunteers came from the following churches: Bishop Cummins Church in Catonsville's Maryland, Grace Church in Collingdale Pennsylvania, St. Timothy's Church in Mount Laurel, New Jersey and St. George's Church in Hamilton, Canada.

We are thankful to the Rev. Jason and Mrs. Ebony Holloway and Rev. Buchanan for providing housing and breakfast to some of the volunteers. In addition, individuals and churches from our diocese delivered very tasty lunches and dinners for the workers. We are also thankful for the generous contributions that were sent to provide scholarship money and funds for miscellaneous purchases. Thanks also goes to all of those that supplied prayer support for us during the planning phase and execution of the project, including the regular meeting for prayer of those from Church of the Atonement in Collingdale, PA. Thanks are also owed to those who donated and loaned equipment. Lastly, Shawn Riley did an outstanding job doing (among other things) planning and coordinating the work and monitoring its progress.

To note some of the work that was accomplished at the Seminary, the bookstore was relocated to the newly purchased building on the expanded campus. During this time David France worked on sorting and reshelving all the books.

The additional work that was done at the newly purchased building was renovation in various rooms, which included removing old carpeting, prepping and repainting walls. The life insurance and disability program has now been transferred to the General Council Board of Pensions and Relief. The new plan has increased levels of coverage and is very affordable. All fulltime clergy are required to participate. The premium for both Life Insurance and Disability Insurance is \$500.00 per year.

Our own history has clearly demonstrated minimum levels of disability protection necessary for our full-time clergymen. As a result, the Committee has established certain policies and repeats its suggestions to our clergy for coverage. These are as follows:

A. That, prior to or in conjunction with joining the group program, each person establish individual disability insurance. The Committee has adopted the following guidelines for financial assistance of disabled clergymen:

The Committee will not be able to provide financial assistance in the event of disability if:

- 1. The clergyman has opted out of Social Security and in addition to membership in the General Council Group plan, has not purchased private disability insurance in benefit amounts of no less than \$1,100 a month with a rider adjusting the benefit for inflation. This minimum figure is necessary to replace Social Security and Medicare benefits that are lost to the clergy by filing of Form 4361.
- 2. The clergyman is still in Social Security but has not joined the group plan and has not purchased individual disability insurance, unless unqualified for health reasons. The new General Council plan provides \$50,000.00 in Life Insurance Coverage and up to \$2000.00 per month of Disability Insurance. The annual premium for the plan is \$500.00 and will be due January 1, of each year. If you are new to the REC or have not yet enrolled, please contact the General Council

Headquarters.

B. A Retirement Plan: The Retirement Plan for our clergy is administered by the General Council Board of Pensions and Relief. This pension program requires churches to make contributions on behalf of their pastors amounting to 12% of the total of the pastor's base salary (less all benefits), his housing allowance and/or fair rental value of the Rectory, and the Rectory utilities. Please note, the pension contribution for 2015 with supporting form is due no later than January 15, 2016. Effective in 2012, the contribution was raised to 12% by action of the General Council of the REC. The plan document allows Churches to make additional contributions to an employee's account in excess of the stipulated 12% amount. This contribution may not be funded by a salary reduction. It must be made directly from Church funds. Checks should be made payable to the Board of Pensions and Relief of the REC and sent to the Board at 25 West Second Street Media, PA 19063. Christian charity and careful stewardship are both mandated by God's Word. The Committee administers the Bassinger Home Fund with an eye to both.

We, once again, encourage the delegates of this Council to advise their parishes regarding the fund and its work. We encourage you to assure that the needs of your pastor and his family are cared for in good health, in disability, in retirement, and in death.

The offering that was taken at Women's Day was to raise \$7500 to assist The Free Church of England in adapting the church building at St. John's Free Church of England Tottington, Bury, UK, as a center for mission and outreach to include a kitchen, lavatories, and community facility.

Karen was raised in the Germantown area of Philadelphia with her parents, Arlene (Nancy) and James Allen. She attended Philmont Christian Academy and studied music at the Settlement School. Karen learned how to play the piano at age three and later added the violin to her musical repertoire. She earned her B.A. in music from Temple University. She also earned a graduate degree from Penn State University in Community and Economic Development.

Karen was employed by the Defender's Association of Philadelphia. She began her twenty-year career as a legal assistant and rose to the position of Systems Administrator.

Karen was a lifelong Reformed Episcopalian. She spent her early years at the Church of the Messiah in Germantown. God opened her heart to His saving Gospel at an early age. Bishop Hicks presented an idea from Diane Jerdan that could benefit overseas missions, in addition to our parishes here. Mrs. Jerdan proposed that parishes try to build into their budgets funding to send pastors or parish leaders overseas to do missionary work. In turn, those pastors and leaders would be bringing home renewed enthusiasm, which would transfer locally. Bishop Hicks would like to build into the Diocesan budget matching funds to help parishes who send their pastors or leaders overseas.

The Bishop announced a five minute Trustees meeting following the closing of Council.

A motion was made, and unanimously passed, to adjourn.

Bishop Gillin offered closing prayer. Council adjourned at 12:55 pm.

FULL TREASURER'S REPORT

To the One Hundred Thirty Fifth Council Of the Diocese of the Northeast and Mid-Atlantic Of the Reformed Episcopal Church Dear Brethren,

NEMA's current financial situation presents significant challenges. In our present situation, deficit spending continues and it is unsustainable. Current assets in checking and investment accounts are a shrinking source of funding. Meaningful planning for ministries and operation in the future is made difficult. This report presents current financial status, the challenges it presents and a summary of actions planned to resolve major contributing issues. A defined course of action and measurement is necessary to avoid the insolvency that is likely in five to ten years time if we were to allow the current financial situation to continue unchecked. Financial actions to be taken will be part of an overall NEMA strategic plan that the NEMA Board of Trustees has directed to be undertaken. Accordingly, the focus of this report is on the future and preparing for it, the past being addressed only so far as is needed to identify things on which to capitalize and things to avoid in the future.

Account Summary

A summary description of the accounts whose status is presented herein is available in Appendix I of this report.

Financial Reports (audited) – Statement of Activities & Statement of Financial Position for Year-Ending (YE) 2013 & 2014 and 2015 Year-to-Date (YTD) September 30, 2015

These reports are available in Appendix II of this report. There are several key points for the reporting period:

In the Statement of Activities;

- † Total revenue was down 22% from 2013 to 2014 and has fallen sharply in 2015 led by a decline in revenue from investments, largely due to a combination of market performance and withdrawals to fund diocesan expenditures. Contributions by parishes ("Parish Tithes") are in steady decline at about a rate of approximately 3% per year
- † Overall expenditures have increased at an annual rate of 3% except during 2015 as it became necessary to advance regular disbursements to RES by one month to maintain positive cash flow
- † Expenditures are currently exceeding revenue by \$227,326.

In the Statement of Financial Position – 2013 to 2014;

† The cash position rose 23% or \$39,900 in 2014 due largely to the sale of the St. Philip's property

- † Investments have declined by 13% or \$183,700 due largely to withdrawals for deposit in operating cash accounts although negative market performance during the third quarter of 2015 has been a significant negative contributor;
- † Mortgage receivables were up 19% or \$315,100 largely due to the sale and subsequent take-back mortgage of the St. Philip's property
- † A significant portion of our Fidelity investments are restricted in the way that they can be used. Included are all of the Benson Fund (\$138,978) and a portion of the Diocesan Investment Account. The latter is estimated to be \$152,458, which amount has been reported in recent history as comprising the Cape St. Clair Fund. The actual amount and the donor's intentions remain in question and the work to resolve the matter is continuing.

Summary of Current Assets

The chart in Figure 1 documents our current assets as of September 30, 2015. Data begins with that provided in the audited reports. The mortgage receivable amount of \$975,000 for First Church, NY, has been added to this summary as both an asset and a liability. This is because the mortgage note is held by the Diocese but is funded by RES. Loan payments are currently "interest only" and that interest is currently being paid to RES. Current interest payments are not accounted as revenue to NEMA.

The assets of immediate concern are: the Diocesan Checking account – used to receive funds from various revenue sources and make disbursements to meet expenses for diocesan ministries, programs and operation; and the Fidelity Diocesan Investment account – used to fund the Diocesan Checking account to the extent that primary revenue sources are unable to fund necessary disbursements. A Statement of Receipts & Disbursements for the Diocesan Checking Account for 2014 and 2015 September 30 YTD is available in Appendix III of this report. Financial performance and trends, which constitute deficit spending, that are evident in 2014 have clearly continued to date during 2015.

ISSUES & ACTIONS

There are really only three ways to end deficit spending – increase revenue, decrease expenses or both. In general, revenue needs to be the focus. It's not possible to save your way to solvency. If expenses are cut to the extreme, the entity that incurs them in order to operate must cease to exist. Revenue that is insufficient to meet expenses will achieve the same end. Both must be addressed together.

NEMA's challenges in the area of revenue are twofold; investment income and contributions from parishes.

Revenue – Investment Income

Too much of our capital is invested in mortgages where returns are earned at a fixed rate, at best. Capital invested in mortgages is not readily available for directly meeting expenses or for investment in instruments that historically provide higher returns. Focus is on income and not growth, the present and not the future. Our mortgage receivables

have grown to the extent to which has resulted in lost opportunity to gain from investments made in instruments with higher returns. It has also strained our reserves held in cash and investment accounts.

Our Fidelity Diocesan Investment Account has lost 29% of its value throughout the reporting period. A substantial cause is the increasing rate of withdrawals, which not only depletes the cash in the account but results in the same effect of lost opportunity as does our mortgage receivables position. Major factors contributing to the decline in the account's value include weak market performance and an investment strategy that trends toward capital preservation and income rather than capital preservation and growth.


Based on these parameters and reviews by independent financial advisors, a new investment strategy is needed and will be implemented as approved by NEMA Trustees as part of the strategic planning program that they have directed. Key elements of the strategy generally will be: to convert investment assets currently held in mortgages to other asset classes; to transition from income-oriented to a growth-oriented investment model.

These are improvements that can be made by the Trustees where practical while the diocesan strategic plan is being formulated, thereby avoiding delay of potential benefits that could result from our investment strategy. At the same time, we will manage the investment's cash position such that capital is held as long as possible for investment before being converted to cash to meet expenses.


Revenue – Parish Tithes

Revenue received in "Parish Tithes" continues a downward trend. A report of receipts in "Parish Tithes" YTD September 30, 2015, is available in Appendix IV of this report. A brief analysis of data submitted by parishes for 2010 through 2014 using the NEMA State of the Diocese survey process reveals the state of the matter.


There are many parishes that have not tithed during the period.



This situation has worsened during the period.



The situation has resulted in the loss of \$258,000 in revenue to the Diocese during the reporting period. The contribution to the 4-year loss has been significant by some individual parishes.



There is no action that the NEMA Trustees can take to address this matter except for measurement and timely reporting of parish contributions to the Diocese. That practice will continue on a regular basis.

Expenses

There is virtually no opportunity to limit expenditures without discontinuing some ministries, programs and/or operation. This fact becomes evident when comparing YE 2014 and YTD 2015 financial performance and using these to produce a budget for 2016.

PROPOSED BUDGET FOR 2016

Appendix V of this report presents the 2016 budget as proposed by the NEMA Trustees for approval by the 135th NEMA Diocesan Council.

RECOMMENDATION: The NEMA Trustees recommend approval of the 2016 NEMA budget as documented in Appendix V of this report.

Transition to Paperless Financials

Significant reduction in the amount of paper used to manage the finances of our diocese could result in corresponding savings of time and expense. Paper requires a large amount of storage space, which is becoming increasingly expensive. Staff time and effort to

search for and retrieve data and information is even more expensive and limited in capability compared to high-speed electronic search and retrieval. documentation of financial transactions can be stored electronically with the transaction itself in the financial software system's data base. The audit for this period has been conducted without the expense of travel or exchanging paper media, everything being accomplished electronically. And we're not being pioneers in this effort. Financial institutions, suppliers, service providers and others have been operating this way for many years and electronic format of what has historically been in paper format is now fully legal and accepted. Indeed, we may not have a "paper choice" available for many financial transactions in the not-so-distant future. In preparation for the inevitable and to begin to now realize some of the economic benefits of paperless transactions, the following policy for regular NEMA payments to parishes or individuals will become effective January 1, 2016. This policy extends and formalizes the practice established during 2015 for the REC's retired Presiding Bishop, NEMA's bishops, the Reformed Episcopal Seminary and the Trustees of the Sustentation Fund of the Reformed Episcopal Church.

The scope of this policy is for regularly scheduled, e.g., monthly and quarterly, payments by NEMA. All such payments to individuals or parishes will be made only by direct deposit to the appropriate account. Approval and authorization for NEMA to use an account for direct deposit is to be provided *in writing* by the individual or, in the case of a parish, by the parish rector and wardens, directly to the attention of the NEMA Treasurer at the Blue Bell HQ address. Attendant with such approval, and in documentation of such for the use of NEMA's Treasurer and future staff, must be a voided check against the account which is to receive the direct deposit.

APPENDIX I

Summary of Accounts

The diocesan financial accounts consist of three (3) checking accounts and three (3) investment accounts. In 2013, the Univest Checking account was closed into the main checking account.

Checking Account Summary

The checking accounts for the Diocese are as follows:

- 1. The Diocesan Checking account is effectively the general operating account for the diocese. It is a Wells Fargo checking account. This account handles the normal accounting activities of the diocese. This account receives the income from Parish Tithes and Investment Fund Transfers and disburses payments to meet the obligations of the Diocese.
- 2. The Diocesan Escrow account is also a Well's Fargo account which is largely inactive. The intent and use of this fund is to be better defined but reportedly has some relationship to Jesus the Good Shepherd Church.
- 3. The St. Philip's account is a Well's Fargo account formed as a result of the rental and sale of the former St. Philip's church. This account is now designated as the bishop's discretionary account from which disbursements are authorized jointly by the bishops and treasurer.

Investment Account Summary

The investment accounts for the Diocese are as follows:

- 1. The Diocesan Investment account is often referred to as the 4.0 account. Financial accounts for the diocese have evolved over time and various funds have been consolidated into this common, co-mingled account. This account is currently being used as a source of income to meet the obligations of the Diocese. This fund contains restricted funds and non-restricted funds. There is no documentation presently available that accurately defines what is restricted, the only reference to restricted funds being one that historically appears in NEMA Treasurer reports. This reference is to a fund titled the Cape St. Clair Fund, which contains the proceeds of the sale of a property in Baltimore that was donated to the Diocese. A review of historical information is being conducted to re-establish the intent of the donor. It is important to retain, where possible, restricted accounts. This account also includes a mortgage for All Saints Anglican Church, Newark, NJ.
- 2. The Parish Development account is often referred to as the 4.3 account and is a non-restricted account. This account had been used to fund general obligations of the Diocese until the May 2014 meeting of the NEMA Trustees, at which point the use of the fund for those purposes was discontinued. This account also includes a mortgage for Jesus the Good Shepherd Church, Brooklyn, NY.
- 3. The Benson Fund is often referred to as the 4.4 account and is a dedicated fund for Grace Church, Collingdale. It is administered jointly by Bill Kozma and the NEMA Treasurer.
